We collect or use the following information to **provide services and goods, including delivery and third party referrals**:

- Names and contact details

We collect or use the following information to receive donations or funding and organise fundraising activities:

- Names and contact details
- Addresses
- Payment or banking details

We collect or use the following personal information for **dealing with queries**, **complaints or claims**:

- Names and contact details
- Address
- Customer or client accounts and records
- Financial transaction information

Lawful bases and data protection rights

Our lawful bases for collecting or using personal information to **provide** services and goods, including delivery and third party referrals are:

 Contract – we have to collect or use the information so we can enter into or carry out a contract with you. All of your data protection rights may apply except the right to object.

- Legal obligation we have to collect or use your information so we can comply with the law. All of your data protection rights may apply, except the right to erasure, the right to object and the right to data portability.
- Legitimate interests we're collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - o Information concerning the research and language-related interests of members is used by IALIC to inform the planning of conferences and events organised by or associated with IALIC. This allows IALIC to benefit members by staging events that are more relevant to members' interests. It is not used for any other purpose. IALIC therefore considers that the benefits to members outweigh the risks involved in sharing this information.

Where event hosts are outside of the UK member personal information is shared under exception 2 of Article 49 of the UK GDPR (sharing is necessary for IALIC to satisfy its contract with the member).
